**Purpose**: the purpose of the meeting is to explore potential forms of collaboration among a network of European universities, which will have representatives in the General Committee of the India Platform UGent. The India Platform UGent intends to play a coordinating and facilitating role in setting up European collaborative research and educational projects related to India in the humanities and social sciences.

We have already established a network of universities in Karnataka, working towards the creation of the Karnataka Academy of Social Sciences and Humanities (KASSH). This will expand and include universities from other parts of India to become the India Consortium of the Platform.

  the Study of Local Cultures at Kuvempu University.

- 13:30 14:30: Brief introduction by each of the representatives of their institution and the research it does related to India (5-10 minutes).

- 15:00 16:00: Discussion of establishing the EU-India consortium for applications to the
  Erasmus Mundus External Cooperation Window and other programmes. The aim is to
  prepare a consortium for the next call of the European Commission for collaboration and
  exchange between European and India Higher Education Institutions (HEIs) and discuss the
  possibility of setting up an Erasmus Mundus PhD Programme of Europe/India Studies.
- 16.00 17.00: Discussion of other potential collaboration: e.g. with Kuvempu University and the Karnataka Academy of Social Sciences and Humanities; applications for the FP7 programme of the European Commission; participation in the Rethinking Religion in India and Rethinking Politics in India conference clusters; building of a European master's programme of India Studies.
