#### The Golden Jubilee Conference

In this 50<sup>th</sup> year since it was founded, the Indian Society of International Law (ISIL) is in the midst of year-long Golden Jubilee celebrations which commenced on 4th February 2008 and will conclude with its Sixth International Law Conference from 1 to 4 February 2009.

As part of the Golden Jubilee celebrations, throughout the year, the Society has organised a number of events including special lectures by eminent scholars of international law, seminars, a moot court competition on international law, publication and release of book on history of the ISIL and an edited book on contemporary challenges to international law. The highlight of these activities will be the *Sixth International Conference* on *International Law in the Contemporary World* where eminent personalities in the filed of international law from a number of countries will participate in discussions on themes which will include (1) The present state and Public International Law (2) Private International Law (3) The significance and impact of the World Trade Organisation (WTO),(4) the expanding regime of Intellectual Property Rights, and (5)International Arbitration. #### About the Indian Society of International Law

The Indian Society of International Law (ISIL) was founded in 1959 at the initiative of V.K. Krishna Menon and inaugurated in the same year by Pandit Jawaharlal Nehru, the first Prime Minister of India. ISIL has been publishing the *Indian Journal of International Law* since its inception, which has attained a high standard and is held in great esteem the world over. ISIL has also a good library, which is used by scholars from all over India. ISIL organizes annual conferences and seminars on international issues of contemporary concerns. ISIL runs Post- Graduate diploma courses in various branches of international law. It also organizes every year a summer course in International Law for students, teachers and lawyers.

#### ISIL International Conferences held Since 2001

ISIL held its **First International Conference on "International Law in the New Millennium: Problems and Challenges Ahead" in New Delhi from 4 to 7 October 2001.** The Conference was inaugurated by the then President Shri K. R. Narayanan and attended by nearly 350 participants, including 25 foreign delegates. In the conference nearly 80 scientific papers were presented. **Second International Law Conference was held from 14 to 17 November 2004,** and was inaugurated by Shri K. Natwar Singh, then Minister of External Affairs, Government of India. Hon'ble Vice President of India Shri Bhairon Singh Shekhawat delivered a special address during the Conference.

*The Emerging Trends in International Criminal Jurisprudence* was the theme of the Conference held on **10-11 December 2005** at the Society's premises. Shri Shivraj Patil, Home Minister of India inaugurated the **Third International Conference** on 10<sup>th</sup> December 2005. Judge Philippe Kirsch, President, International Criminal Court, also addressed the session.

**The Fourth International Conference** on "*Private International Law*" from **2-3 December 2006** was organised in collaboration with *T.M.C Asser Institute* and the *Hague Conference on Private International Law*. Shri Vyalar Ravi, Minister of Overseas Indian Affairs, inaugurated the conference on 2 December 2006.

The Fifth International Conference was held from 8 to 10 December 2007. Prof. Thomas M. Franck, Professor of Law, New York University of Law, inaugurated the conference. The themes of the Conference discussed on 8-9 December were International Environmental Law and Recent Trends in Teaching and Research in International Law. The theme for 10 December was the Law of the Sea, when a special seminar was organised to commemorate the 25<sup>th</sup> anniversary of the adoption of the United Nations Convention on the Law of the Sea.

#### **Registration Fee**

A nominal fee of Rs. 1500/- is fixed for Indian as well for foreign delegates as registration fee. As seats are limited, preference would be given to delegates from outside Delhi. Registration will cover a, Conference kit, participation in the inaugural Reception and the concluding celebration/ cultural programme; as well as Lunch and Tea during the Conference working days.
